â?¢To carry personal responsibility for compliance with Health & Safety obligations (including food safety, fire safety and insurance requirements) as documented in the Fledglings Early Years Education and Care policies and procedures folder (which will incorporate the requirements of the relevant Safety, Health and Welfare at Work Act).

â?¢To carry personal responsibility for compliance with Child Protection obligations as documented in the Fledglings Early Years Education and Care policies and procedures folder (which will incorporate the relevant policies and procedures from OMCYA as documented in â??Children Firstâ?•)

â?¢To minimise wastage and costs in the storage and disbursement of all consumables required for the provision of the childcare service.
