Successful candidates will be expected to respect confidentiality at all times. Candidates must demonstrate practical experience with the management of challenging behaviour and promotion of positive behaviour based on strategies which are suitable in Sligo School Project. Candidates must demonstrate practical experience with conflict resolution. Manual handling experience and ability is also essential.
