Trainer/Keyworker – RT Programme

Specified purpose contract, Full time 37 hours per week. (Monday to Sunday roster, 8am-8pm). Flexibility to work some evenings and weekends as required is essential as services are delivery in line with the needs of the individuals.

A vacancy has arisen for the above post on our Rehabilitative Training Programme in Adult Services, CRC. In Line with New Directions policy 2012, the aim of our Training programmes is to support Adults with disabilities in obtaining the necessary academic knowledge, skills, experience and confidence to lead self-determined lives within their community.

As a Trainer you will design, deliver and assess QQI modules, achieve the required standards, support the students in attaining their qualifications and assist them with progression plans. You may be required to work across our programmes, delivering non-accredited and accredited modules. On the Rehabilitative Training Programme modules range from QQI Level 1 to 4.

In addition, as Keyworker you will be responsible for supporting a group of Adults onsite and in the community, working with them in a one to one capacity, helping them to develop their Individual Training Plans, which will support them in achieving both their academic and personal goals.
