1. Additional childcare and/or other relevant qualifications or courses (e.g. First Aid, Manual Handling, Positive Behaviour Support Strategies etc.) would be highly desirable.
2. Knowledge and experience of working with pupils in a mainstream setting with ASD, ADHD, Down Syndrome, deaf community, tube feeding, diabetes and/or intimate care needs would be highly advantageous.
3. Knowledge of systems to support children who experience difficulty communicating e.g. LÃ©mh, PECS etc. desirable
4. Flexibility, team work and initiative to work independently and as part of a team. The school ethos is very important to us and therefore innovation, communication and collegiality are vital to

be the role.
