The Job

Early Childhood Ireland is seeking an experienced instructional designer/educational technologist who will, as part of a Research and Professional Learning (RPL) team that includes subject matter experts, coordinate and deliver online/blended CPD courses and learning opportunities to our members and the early years sector; from an analysis of learning needs and goals, to the design and development required to deliver a system to meet those needs.

The Person

The successful candidate will have a proven track record in online/blended course design and development. The candidate must have knowledge and experience of adult learning models and methodologies. Expertise in developing programmes in early education and/or school age childcare (SAC) would be advantageous, or expertise in a cognate area to SAC, e.g., playwork, youthwork, education.

Job Purpose

Early Childhood Ireland's vision is that every child is thriving and learning in early childhood settings. Early Childhood Ireland supports our members and the early years workforce to improve the quality of practice and services through classroom-based, online, and blended approaches to continuous professional development and learning. The successful applicant will play a central role in delivering high-quality learning opportunities to Early Childhood Ireland's members and to the early years sector.

- Storyboard and write scripts with input of RPL team, ECI partners and subject experts.
- Coordinate and support video development, live training sessions, webinars, etc.
- Support the development of an online organisational Learning Management System.
- Assist with the development of learner engagement strategies.
- Research new ideas and proven methods in online/blended learning.

 Project manage multiple design and development projects using project management methods and tools.

Quality assurance and programme effectiveness

 Assist in the development of a quality assurance framework for Early Childhood Ireland's continuous professional development and learning programme.

 Develop and maintain high-quality programme documentation for programme monitoring and evaluation, and compliance/accreditation purposes, with the support of the Research and Professional Learning administrator.
