The new school will be located in Limerick City.

-     Be fully registered with the Teaching Council under Route 1 (Primary), Route 4 (Other) or Route 2 (Post Primary) with the Teaching Council
-     5 years recognised teaching service, two of which must be in a recognised primary or post primary school within the Republic of Ireland.
-     Significant experience with children who have a diagnosis of Autism/Autistic Spectrum Disorders and/or Special Education Needs is desirable.
-     A post-graduate qualification in Special Education is desirable.
