The Harold School has an Autism Class (Special Class (ASD-Junior)). SNAs may work in mainstream, our Autism Class or a combination of both. SNA class placement is reviewed annually in line with the developing needs of the children. Applicants should have qualifications as per Department of Education & Skills Circular 0030/2019.

Candidates must be able to work well as part of a team, be flexible, display strong work ethic and demonstrate a willingness to avail of further training. We are inviting applications from candidates who have experience of working with children with ASD and who have a strong knowledge and experience of positive behaviour support strategies. Duties include catering for care needs such as toileting, dressing and feeding, supporting students with challenging behaviour, assisting pupils in the swimming pool. It would be desirable for candidates to have some experience of using PECS, TEACCH or LÃ_imh.

Appointment is subject to current vetting requirements, Occupational Health Screening and completion of the online TUSLA Child Safeguarding training.
