The successful applicant must be able to work the hours during times agreed by the Principal/Board of Management.

They must be able to take up the position as soon as possible.

Ideally, applicants will:

- Have general maintenance skills
- Have an understanding of caretaking duties
- Be willing to work cooperatively with school staff and management

Duties will include:

- Inspections of premises
- General school repairs
- Maintenance of buildings (internal and external)
- Development and maintenance of school grounds and green areas
- Maintenance of furniture and fittings
- Liaising with external contractors where relevant
- Opening/closing of school
- Keyholder and alarm duties
- Management of disposal of waste

There is an initial probationary period of 6 months.

â° A Safe Pass and any other relevant training.
