Candidates must be able to work well as part of an enthusiastic and energetic team of teaching and non-teaching colleagues, be good communicators, be flexible, display a strong work ethic and demonstrate a willingness to engage in further training. One of the posts advertised here is a standard permanent part-time post (0.83 post, 26.56 hours weekly), and the other is a standard permanent part-time post, (0.75 post, 24 hours weekly) with additional Croke Park hours.
